

## School Choice Scholarships: 2012-2013 School Year Scholarship Application

Since 1998, working to provide low-income families throughout Kentucky with quality educational choices

### Who can apply for a School Choice Scholarship?

#### In order to apply for a School Choice Scholarship, a child must:

- ▶ Live and attend school in Jefferson & Oldham County, Kentucky
- ▶ Be entering Kindergarten (K) through Sixth (6) in the Fall of 2012
- ▶ Be Eligible for assistance under the Federal Lunch Program

### Can you tell me more about the School Choice program?

Students who are awarded a scholarship, receive assistance up to \$2,000 of the annual cost of attending school.

Students can attend any private, independent, special needs, parochial or church-based schools located throughout Jefferson or Oldham County- it's the family's choice which school is **best** for their child.

School Choice believes a certain address or a lower income shouldn't limit a family's choice of schools.

Students can reapply & **provided** they meet criteria for the program & **funding** is available, be awarded scholarships through eighth (8) grade.

Scholarship payments are paid directly to the child's school, in 3 installments over the year.

### School Choice Program Details:

A School Choice scholarship can help offset the cost of your child attending the quality school of your choice, **provided:**

- 1.) Student remains in good standing with their school during their time in the program,
- 2.) Student and the family participates in all School Choice evaluation projects,
- 3.) Family turns in all required School Choice paperwork on time & complete
- 4.) Family pays their portion of school fees & tuition on time
- 5.) Family meets all requirements of the School Choice Family Meeting Program

### How are the scholarships awarded?

Scholarships are awarded through a yearly scholarship drawing.

Scholarships are awarded without regard to religion, race or ethnicity.

Incomplete, late & non-eligible applications are NOT considered for scholarships.

Please be aware that submitting an application does NOT guarantee a scholarship.

### What about my child's SIBLINGS?

Scholarships are awarded to all eligible children in a family!

If one child in a family is awarded in our May scholarship drawing, their siblings who apply & are entering grades K to 6 in the Fall of 2012 will also be awarded scholarships.

Once the award year of the scholarship begins in the Fall of 2012, no new siblings are added to the program.

### Do I have to pick a certain school?

**No**, the School Choice program is built on the core principle that parents **can and will** choose the best schools and the best education for their children.

## How much is a School Choice Scholarship?

A School Choice scholarship can offset up to \$2,000, the yearly cost of your child attending the quality school of your choice in Jefferson or Oldham County.

## Why not pay the whole tuition?

School Choice seeks to honor and support parents who are sacrificing to give their children greater educational opportunities. We provide a helping hand up, not a hand out.

## Is the scholarship just for public school students?

Our goal is to reach as many new families as possible, who have never felt they had the option of choosing their child's school.

Therefore, students who are new to private school will be given preference for scholarships in the drawing.

## What about transportation?

As with most parents who choose educational alternatives, School Choice parents are responsible for their child's daily transportation to and from school.

## How do I apply for a School Choice scholarship?

Families submit a complete application with all required documentation, **to the school** they want their child to attend in the Fall of 2012

**Only one application per family is needed**

**Each year**, all previous Scholarship applicants & recipients **must submit** a complete application with supporting documentation, to be considered for scholarships.

Make sure to keep copies of all the forms you submitted to our office for your records  
You are responsible for notifying School Choice in writing of any change in email, address, phone number, school, etc.

I understand I am only at this time applying for a SCS scholarship and that there is NO guarantee that my child/ren will be awarded a SCS scholarship.

I certify that my child/children qualify for the Federal Free or Reduced Price Lunch Program. I certify that my child/ren live and attend school within the boundaries of Jefferson or Oldham County, Kentucky. I certify that I/we possess sufficient resources and funds, to cover tuition costs or other school fees not covered by any scholarship award.

I certify that all financial and other information provided with my application is true and complete. If I do not file taxes, I realize I am responsible for obtaining proof of this fact before applying to the SCS program. I realize this information will be verified with Internal Revenue Service, before my application will be accepted. If my child/ren are accepted into the SCS program and documentation/information is found to be fraudulent or any attempt to falsify documentation and/or information submitted to School Choice Scholarships, Inc. will result in my child's application and/or scholarship being immediately revoked and there will be no other obligations to us. If my child is currently in the SCS program when fraudulent information is found, no further monies will be paid for the scholarship. If our family is removed from the SCS program, we will be financially responsible to my child/ren's school(s) for any and all remaining monies. I realize all information included will be verified with any other applicable agencies. If I receive any type of benefits, all benefit letters have been included with this application and this information will also be verified applicable agencies. Scholarship grant awards are the sole responsibility of School Choice Scholarships, Inc. and all decisions are final and can not be appealed. I agree to fully release and hold harmless School Choice Scholarships, Inc., any and all its staff, Board of Directors, donors, schools and volunteers from any and all past, present and future liabilities in its efforts to provide this scholarship, projects, evaluation programs, meetings and programs.

I understand, accept that all information at Family Meetings presented is voluntarily presented and is not given as medical or other professional advice. I realize that must attend **2** (two) events and complete my fall survey by December 2012, in order to receive any holiday type incentives that may be offered. If before February of 2012, I fail to attend **2** (two) events and my complete fall survey, no further scholarship payments will be made for my child that school year and my child will be removed immediately from the School Choice program and that my family will not be eligible to apply to the SCS program in any subsequent years. I realize if our family is removed from the SCS program, my family will be financially responsible to my child/ren's school(s) for any and all remaining monies due to the school(s).

## Application Checklist & Reminder Page

### For Tax Returns & Taxes:

- Include complete & signed 2011 Federal 1040 Tax Return for all income earners in your home, Include all pages of returns

- Tax returns must include the names of all adults & children claimed as members of your household

Income earners include: married couples, stepparents, unmarried couples living together, who may or may not be the biological parents of any or all children in the household and any other adult members of the household over 21, who do not currently attend school

- Married or unmarried couples who are filing separately must send **both** returns
- Must include copies of all returns for your business, corporations, self employment, etc.
- If you submit an incomplete tax return, your application **will not** be accepted.
- For a copy of your 1040 or letter or non-filing of taxes letter, please call the IRS at 1-800-829-1040
- If you **do not** file taxes- you must have a letter from the IRS documenting this fact for the prior tax year (2010) If you do not include this IRS letter as documentation, your application will NOT be accepted.

### For W2's & 1099's:

- Include copies of **all** 2011 W-2's or 1099's for all jobs, income & businesses, for all income earners in the household

*Income earners include: married couples, stepparents, unmarried couples living together, who may or may not be the biological parents of any or all children in the household & any other adult members of the household over 21, not currently attending school*

### For Paystubs & Self-Employed:

- 2 current paystubs for **each** job must be included (within 60 days of applying)
- If you are Self Employed- please include 2 months bank statements due to not having paychecks

### For Child Support Documentation:

• Child Support Documentation must be included for **all** children, even those you are NOT applying for scholarships & for children you do not receive support on- see page 3 & 5 for more information

- Include Documentation of any & all other forms of income, See page 3 & 5 for complete list.

- 2 current, different types of utility bills (within 60 days of applying)

Examples: telephone, electric, water, cable (within 60 days of the date of your signed application).

These must have the name & address of the adults who are applying for a scholarship.

- **NO** handwritten notes or driver's licenses are ever accepted
